# PRE AUTHORIZED REMITTANCE FOR MARTIN LUTHER CHURCH, TORONTO

## **What is pre authorized remittance?**

Pre authorized remittance is a direct debit program that allows people to support the church through an automatic monthly withdrawal from their bank account. This debit would be similar to other authorized withdrawals from your account, i.e. utilities, condo fees, car payments, property taxes.

At the beginning of the year or when joining the program, the congregation member would determine the amount of the monthly remittance to the Martin Luther Church, Toronto. At any point during the year with 15 days notice, the congregation member may decide to change the amount of the donation or cancel the remittance. The monthly remittance will be withdrawn from your account on the 10<sup>th</sup> of each month.

## **Advantages of pre authorized remittance:**

- Regular support of the church in the amount that you chose
- Continual support of the church when you are away
